The 2020 Annual Town Meeting is scheduled to begin at 12:30 PM, with gates opening at 10:30 AM, on Saturday, September 12th. The Special Town Meeting is scheduled to begin at 1:00 PM, within Annual Town Meeting. Due to the COVID-19 pandemic, the Town will be taking precautionary measures to reduce the potential of virus transmission during our annual meeting. The Selectmen will be holding a Virtual Warrant Hearing on September 8, 2020 at 5:00 PM in which every article and its motion will be reviewed and discussed.
